And, what does “The NPV ‘preserves’ the Electoral College” actually mean? It means that they are constrained by the Electoral College and CAN’T get rid of it, despite their strong desire to do just that! It also means that **these will always be NORTH CAROLINA’s Votes to cast to elect the President of the United STATES!**

ONLY IF North Carolina joins the NPV contract scheme will North Carolina voters exert just 3.5% of the decision of who NORTH CAROLINA Votes for! The other 49 States – even the ones who refuse to join this terrible NPV contract – plus DC, will make 96.5% of NORTH CAROLINA’s choice! There are 7 States who will EACH have a stronger voice in who North Carolina Votes for than what North Carolinians will have! **The State of OHIO, at 3.7% of the “national popular vote”, will exert more control over who North Carolina Votes for than anyone from North Carolina will have! Florida voters will control 7.0% of NORTH CAROLINA’s Votes!**



When NON-North Carolinians control 96.5% of North Carolinian’s Votes, do you REALLY think that the political campaign apparatus will spend MORE time in North Carolina, as the NPV sales pitch promises, or less?!

But it gets even WORSE -

The NPV is **NOT** a national law, despite what you have been left to believe. It is a simple CONTRACT of Collusion among 20 or 21 States. **Probably 27, 28 or 29 of our 50 States will never join this dangerous NPV scheme!**

That means under the NPV scheme, all 49 OTHER States control who **NORTH CAROLINA Votes for, while North Carolina voters are given NO SAY WHATSOEVER in the decision of who the 27 to 29 NON-Compact States Vote for! Ohio and Florida combined will control 10.7% of North Carolina’s choice, but North Carolina voters will get NO SAY whatsoever in either Ohio or Florida! That is because Ohio and Florida – and 25 or more other States – will not join this dangerous National Popular Vote scheme and will keep 100% of their OWN Votes!**

The National Popular Vote Interstate Compact scheme is simply a Contract among a few States that makes voters across America very UNEQUAL!

PLEASE urge your Lawmakers to STOP the National Popular Vote in North Carolina.
